EMAS Registration costs

The following summary provides an overview of the Member States that have confirmed the existence of registration costs as of May 2023.

Austria

A registration fee only for the initial registration. The amount is 508,71 €.

Denmark

- Application and registration cost 2.000 DKK or 4.000 DKK (depending on number of sites, 1-3 or 4 and above)
- Renewal of application every year cost 1.000 DKK or 2.000 DKK (depending on number of sites, 1-3 or 4 and above).

Finland

The fees for EMAS registrations are based on the Decree of the Ministry of the Environment (180/2022)

1. Fee for the registration

a) registration fee for organisations operating at one site or for the first site of the organisation

2. Fee for the update of the registration

The fee for the renewal of the registration will be charged according to the number of sites included in the organisation,

a) fee for the first site (5 h)	420€

c) fee for the each individually registered site (5 h)	420€

3. Fees for the suspension, deletion or refusal of the registration

a) Fee for the suspension of the organisation from the register according to article 15.4 of the EMAS regulation (EC) No 1221/2009 is $672 \in (8 \text{ hours})$ and in addition $84 \notin$ hour for the exceeding hours.

b) Fee for the suspension or deletion of the organization is $672 \in (8 \text{ hours})$ and in addition $84 \notin$ /hour for the exceeding hours if the organisation is suspended or deleted from the register according to the above mentioned regulation except article 15.4. However there is no fee for the suspension if it is based on article 15.2.

c) The fee for the refusal of registration according to article 13 is equivalent to the fee for registration. However, there is no fee for the refusal of the registration if it is based on article 13.5.

d) There is no fee for the lifting of the suspension.

e) If the organisation or part of it is deleted from the register at its own request, the fee is 126 €.

Hungary

The rate of the initial registration fee is from 10.000 HUF to 400.000 HUF. The Decree of Ministry of Agriculture No. 14/2015. (III. 31.) about the administrative service fees of authority procedures for environment and nature disposes of the initial registration fee in Hungary.

Italy

Accredia – Accreditation Price List

Annual fees:

- 50.00 € for small companies,
- 500.00 € for medium companies,
- 1,500.00 € for large companies.
- Public organisations are exempt from paying the registration fee.

The fees refer to each registration number and must be paid each year.

Malta

The registration fees depend on the size of the organisation. The fees apply both for initial registration and for annual renewals.

- 1200 € large organisations,
- 700 € medium organisations,
- 200 € Small organisations,
- 100 € Micro SMEs.

Portugal

The fees vary and depend on the size of the organisation as well as whether it is initial registration, renewal under article 6(1) or renewal under article 6(2).

Currently the fees to be applied are:

- Registration and renewal (article 6(1)) registration of microenterprises: 605,50 €
- Registration and renewal (article 6(1)) registration of small enterprises: 908,25 €
- Registration and renewal (article 6(1)) registration of medium-sized enterprises and local authorities (small): 1 211,00 €
- Registration and renewal (article 6(1)) registration of organisations not included in the previous points: 2 422,00 €
- Renewal (article 6(2)) registration of micro enterprises: 302,75 €
- Renewal (article 6(2)) registration of small enterprises: 454,12 €
- Renewal (article 6(2)) registration of medium enterprises and local authorities (small): 605,50 €
- Renewal (article 6(2)) registration of organisations not included in the previous points: 1 211,00€

Slovakia

In Slovakia, new organisations or those reapplying for EMAS registration are charged a fee based on the number of employees and annual balance sheet or sales. This fee is paid once at the beginning. For registration extensions, organisations pay a lower fee every three years.
